

- TREES, OR OTHER VISUAL OBSTRUCTIONS MAY EXCEED 24 INCHES IN HEIGHT WITHIN VISION CORNER EASEMENTS PLATTED HEREON. SAID VISION CORNER EASEMENT IS GRANTED TO THE CITY OF WAUKESHA. NO DIRECT VEHICULAR ACCESS IS ALLOWED OVER ANY VISION CORNER EASEMENT.
- 13) THERE SHALL BE A 10 FOOT WIDE TEMPORARY SLOPE EASEMENT ACROSS THE STREET OF ALL LOTS. SAID EASEMENT NOT TO BE PERMANENT IMPROVED AND TO BE IN EFFECT UNTIL CONCRETE SIDEWALK IS INSTALLED.

## **UTILITY EASEMENT PROVISIONS**

An easement for electric, natural gas, and communications service is hereby granted by HABITAT FOR HUMANITY, Grantor, to WISCONSIN ELECTRIC POWER COMPANY and WISCONSIN GAS, LLC, Wisconsin corporations doing business as We Energies, Grantee,

Grantee, and A WISCONSIN CORPORATION DOING BUSINESS AS WE ENERGIES, TIME WARMER CABLE MIDWEST, LLC AND WISCONSIN BELL, INC DOING BUSINESS AS AT&T, Grantee their respective successors and assigns, to construct, install, operate, repair, maintain and replace from time to time, facilities used in connection with overhead and underground transmission and distribution of electricity and electric energy, natural gas, telephone and cable TV facilities for such purposes as the same is now or may hereafter be used, all

in, over, under, across, along and upon the property shown within those areas on the plat designated as "Utility Easement Areas" and the property designated on the plat for streets and alleys, whether public or private, together with the right to install service connections upon, across within and beneath the surface of each lot to serve improvements, thereon, or on adjacent lots; also the right to trim or cut down trees, brush and roots as may be reasonably required incident to the rights herein given, and the right to enter upon the subdivided property for all such purposes. The Grantees agree to restore or cause to have restored, the property, as nearly as is reasonably possible, to the condition existing prior to such entry by the Grantees or their agents. This restoration, however, does not apply to the initial installation of said underground and/or above ground electric facilities, natural gas facilities, or telephone and cable TV facilities or to any trees, brush or roots which may be removed at any time pursuant to the rights herein granted. Structures shall not be placed over Grantees' facilities or in, upon or over the property within the lines marked "Utility Easement Areas" without the prior written consent of Grantees. After installation of any such facilities, the grade of the subdivided property shall not be altered by more than four inches without written consent of grantees.

The grant of easement shall be binding upon and inure to the benefit of the heirs, successors and assigns of all parties hereto.

### HOME OWNERS ASSOCIATION NOTIFICATION:

The Home Owners Association (HOA) and/or its agents, employees or independent contractors shall have the right to enter upon any lot, at any time following at least twenty four (24) hours advance written notice, for the purpose of inspection for compliance with the City Master Grading Plan. In the event a lot is not in compliance with the City Master Grading Plan, then the HOA shall give written notice to the owner of the non-compliant lot. If the owner of the non-compliant lot has not brought the lot into compliance with the City Master Grading Plan within thirty (30) days, then the HOA may enter onto the lot for the purposes of bringing such lot into compliance with the City Master Grading Plan, and may charge the lot owner for the necessary costs of such work, and may have a lien against the lot for the same. In the event that the HOA is not in existence or otherwise fails to act then any lot owner who is aggrieved by a failure to comply with the City Master Grading Plan may independently enforce this section by bringing an action in the Waukesha County Circuit Court, and the prevailing party in any such action will be entitled to recover its reasonable costs and attorney fees.



SURVEYOR'S CERTIFICATE

Stigler, Professional Land Surveyor, being first duly sworn on oath, hereby depose and say that I have surveyed, divided and mapped AEROSHADE SUBDIVISION being a subdivision of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of Section 2, Town 6 North, Range 19 East, City of Waukesha, Waukesha County, Wisconsin bounded and described as follows: Commencing at the Southwest corner of the Southeast Quarter (SE ¼) of said Section 2 being marked by a concrete monument with brass cap; thence North 00°42'53" East 1350.56 feet along the west line of said Southeast Quarter (SE ¼); thence South 89°12'05" East 37.40 feet to the east right-of-way line of Oakland Avenue and the place of beginning of the lands herein described; thence North 00°27'22" East 397.94 feet along the east right-of-way line of Oakland Avenue to the northwest corner of the Plat of Wardrobes Addition to Village of Waukesha (now City); thence continuing North 77°04'20" East 361.49 feet along the south right-of-way line of the former Chicago & Northwestern Railroad Right-of-way (now Wisconsin and Southern Railroad Right-of-way) to the West Right-of-way line of N.
