RE: 2023 Pavement Resurfacing

The bids for the City's 2023 Pavement Resurfacing project were opened by the City Public Works Department at 11 am on Friday April 28, 2023. There were three (3) bidders which are shown in the table below. The water utility work for this contract includes approximately 3,200 feet of water main replacement on Richard St. and Debbie Drive, both with limits from West Avenue to Grand Avenue. Due to the close proximity to other City planned resurfacing work, the decision was made to collaborate projects and bid as one project.



Action by the Board of Public Works took place on May 4<sup>th</sup>, and the low bid was approved by Common Council on May 16, 2023. Therefore, I am requesting to ratify and approve of the Water Utility's portion of the low bid in the amount of \$867,279.98. Please note, as with the Delafield and Broadway project bid approvals, we are also requesting approval of the supplier material costs as noted.

This project was approved as part of the 2023 budget and the engineering estimate, including both material and labor, for the Water Utility Portion of the project, was \$1,214,000.00.

The funds that have been budgeted in account 3431 for this project, however these costs do not include Waukesha Water Utility labor.

***Recommended Motion:*** Move to ratify and approve the water main replacement unit price contract and 1% city administration fee totaling \$875,952.78 for the Waukesha Water Utility's portion of the City of Waukesha Public Works contract with Wolf Paving for the 2023 Pavement Resurfacing project. In addition, approve the supplier material costs for this project in the amount of \$191,900.30.
