Review and act on Contract Change Order #1 with State Contractors, Inc. for Summit Ave/Delafield St – Phase 2 Utility and Street Improvements.

Details:

This Contract Change Order explains additional work to be completed by State Contractors, Inc. The additional work in this change order will be paid for with additional quantity on contract bid prices.

- The section of Delafield Street between Bidwell Avenue and Prospect Avenue is in need of complete reconstruction.
 The project limits currently extend to Bidwell Avenue. Using unit bid prices in the contract, the addition of
 \$325,538.46 will reconstruct another 295 feet of Delafield Street from the existing limits at Bidwell Avenue to north of
 Prospect Avenue. The additional quantities are to be paid at contract unit bid prices and are explained in Attachment
 A.
- 2. A safety improvement project that is 90% federally funded is scheduled for the spring of 2017 for the intersection of Northview Road and N. Grandview Boulevard. The amount of pavement repair/replacement on this project is limited by federal and state rules. In order to ensure the effectiveness and longevity of this project, additional existing concrete pavement removal and replacement is required. Using unit bid prices in the contract, the addition of \$149,350.00 will replace 18,000 sq. ft. of concrete pavement within the intersection limits. The additional quantities are to be paid at contract unit bid prices and are explained in Attachment B.

Due to the favorable bids received for the Summit Avenue / Delafield Street project, the City of Waukesha Department of Public Works recommends completing this additional work.

Options & Alternatives:

The work could be done in the future, but with State Contractors, Inc. working near the project limits of the additional work and already mobilized the work can completed at a lower cost.
