Grant Conveyance of Rights, and Temporary Construction Easements to the Wisconsin Department of Transportation as part of the West Waukesha Bypass.

Details:

The Conveyance of Rights:

Existing Storm Sewer Easements were granted to the City of Waukesha (identified as 602 on the attached plat) when various developments were approved adjacent to Merrill Hills Rd (CTH TT). A portion of these easements have now been purchased and dedicated as Right of Way for West Waukesha Bypass. The Conveyance of Rights document removes the easement document from the West Waukesha Bypass right-of-way. The City has no sewer structures located within these easements. The easements that are to be released are:

Temporary Construction Easements:

Existing easements were granted to the City of Waukesha when various developments were approved adjacent to Merrill Hills Rd (CTH TT). These are also identified on the attached plat as 602. A portion of these easements will now be within grading and or construction limits. This document allows the Wisconsin Department of Transportation to enter and perform construction work on an easement previously obtained by the City of Waukesha. The types of easements that are affected include:

- 30-Ft Drainage/Storm Sewer Easement
- 30-Ft Public Storm Sewer Easement
- 66-Ft Utility Easement (Torhorst Rd a private road)
- Drainage Facility Easement
- 50-Ft Drainage Easement
- Storm Sewer & Drainage Easement



Options & Alternatives:


If the City retains the easements, the construction of the West Waukesha Bypass would be in jeopardy because the WisDOT would not receive the necessary right of way certification.







TEMPORARY CONSTRUCTION EASEMENT

(Traditional Right-of-Way Plat)

Wisconsin Department of Transportation Based on DT2216 11/2016

City of Waukesha, Grantor, which has an interest in the lands described below, grants to the Wisconsin Department of Transportation (WIDOT), Grantee, the right and permission to occupy Grantor's easement area for highway improvement purposes, which may include but are not limited to: 1) Constructing slopes and drainage facilities on the following described lands, including the right to operate necessary equipment thereon; 2) The right of ingress and egress, as long as required for such public purpose, including the right to preserve, protect, remove or plant thereon any vegetation that the highway authorities may deem desirable to prevent erosion of the soil, provided such activities are consistent with the rights held by the Grantor under its easement.

The said lands are situated in the City of Waukesha, Waukesha County, Wisconsin and are shown on Sheet Number(s) 4.21, 4.22, 4.23 & 4.24, which is a part of the Right-of-Way Plat for Project No. 2788-00-22, filed with the County Clerk and County Highway Committee of the said County as required by Wisconsin Statutes. This plat is also available for viewing at the Office at 515 W. Moreland Blvd, WaukeshaWI.

The said lands are part of Parcel(s) 101,102, 104, 106, 107, 108, 109, 127,132,133, 134 &136 as shown on said Right-of-Way Plat and are further described as lying in the SE1/4-NE1/4 and NE 1/4-NE 1/4 of Section 6, T6N, R19E, City of Waukesha; in the SE 1/4-SE 1/4 and NE 1/4-SE 1/4 of Section 31, T7N, R19E, City of Waukesha.

This Temporary Construction Easement establishes the right of Grantee to occupy lands on which Grantor has easement interests. However, Grantor reserves to itself the right to continue to use said easement area with its present and future overhead and/or underground facilities in a manner which is consistent with this grant, and further, that the costs of any relocation or alteration of any facilities of Grantor required by Grantee to accomplish its work, now or in the future, will be paid by Grantee.

This Temporary Construction Easement shall terminate upon completion of Construction Project No. 2788-02-70 & 2788-00-72 for which this instrument is given, or n/a, whichever comes first.

The Grantor has a prescriptive right or an easement and therefore grants this Temporary Construction Easement as a holder of a property interest and not as a property owner.
