Please be advised that we have been retained by Secura Insurance, A Mutual Company, the property insurance carrier for Anthony Benz. On December 11, 2016, Mr. Benz was driving east on W. Paul Avenue approaching S. Moreland Boulevard when a City of Waukesha snowplow, traveling south on S. Moreland Boulevard, made an illegal left-hand turn from a right-hand-turn-only lane onto the path of Mr. Benz, forcing Mr. Benz to take evasive action and strike a nearby telephone pole and fence. At the time of the accident, City of Waukesha employee James A. Hart was operating the snowplow. As a result of the accident, Secura has paid to or on behalf of Mr. Benz the sum of \$16,186.55. Accordingly, we now look to the City of Waukesha for reimbursement.

Please be advised that we have been authorized to file suit against the City of Waukesha if we do not hear from the City of Waukesha or its attorney within 120 days of this letter.
