# **City Administrator Highlights**

### Week of April 17:

- Met with Lee Szymborski of GOVHR to discuss the IT Director recruitment and narrow down the field of candidates
- Held the bi-weekly Director's Meeting with all Department heads.
- Participated in the Moody's rating call for the City's bond rating.
- Along with the Mayor, met with Dean Lemke to discuss his new role as Aldermen.
- Held regularly scheduled meetings with Fred Abadi, Chief Howard, and Chris Pofahl.
- Met with Ron Grall and Joanna Adamicki from Parks to discuss Tribute Tuesday and other logistics of summer events.

## Week of April 24:

- Along with Rebecca and the rest of the Leadership Class, participated in a Service Project at the Hebron House.
- Along with Rebecca, held the last class of our Leading Waukesha program. We will be starting with a new group of participants in the fall.
- Held IT Department Director interviews on Tuesday and Friday.

### Assessor

- Assessment notices were mailed out on April 21, 2017. All properties were reassessed this
  year and all homeowners should have received notices.
- The Assessor's Office will be holding informal discussions or "Open Book" from April 24 thru
  May 12. During this time period, property owners can contact the Assessor's Office to ask
  questions about their new assessment.
- The Board of Review is the next level of appeal if the property owner is not satisfied with their assessment after talking to the Assessor's Office. The first meeting of the Board of Review is scheduled for May 22, 2017 at 8:00 AM in the Council Chambers at City Hall. To



appear before the Board, a property owner must file a "Notice of Intent" with the City Clerk at least 48 hours prior to the first meeting of the Board. They must also file a written "objection form" with the City Clerk prior to or within the first two hours of the first Board meeting. An appointment is necessary to meet with the Board of Review.

# **Community Development**

#### **Information Technology**

IT will begin to roll out 64 new PC's. IT is experimenting with a new approach to the PC replacement schedule. Rather than blindly replace PC's based on their age, IT is taking a more analytical approach and replacing based on user needs and PC performance. In addition, the PC's that are not replaced this year will get a memory upgrade to boost performance, and also be upgraded to Windows 10 to take advantage of security features.

#### **Finance**

- We had our Moody's rating call on April 19, 2017. Moody's rating agency has rated the City's upcoming debt issues as follows:
  - 12.8m of GO Promissory notes Aa2 (which is the same as last year and is the 3<sup>rd</sup> highest possible)
  - 4.4m of GO refunding bonds Aa2
  - 9.9 Note Anticipation Notes 5 year Aa2
  - 8.4m of Note Anticipation Notes 1 year MIG1 (best short term rating)

- 6.5m Sewer System Revenue Bonds Aa2 (which is outstanding for revenue bonds)
- Overall, the City received very good ratings based on its credit worthiness, economic strength and overall tax base. These rates allow the City to borrow at extremely low rates.
- The closing of the 2016 books continues to be the main focus.
