We hereby propose to furnish all materials and perform all labor necessary for the completion of:

- Tear-off existing rubber roof system on front porch of home
- Remove existing siding where applicable for rubber roof install up to 12" from the roof
- Remove existing railing system and dispose of
- Remove existing shingles and metal roofing in rubber transition area
- Remove existing downspout extension over rubber roof and reinstall after rubber installation
- Shelter From The Storm to comply with all OSHA safety regulations
- Shelter From The Storm to acquire all appropriate permits if required
- Shelter From The Storm to provide for removal of all jobsite debris
- Install fiberboard under rubber roof system
- Install 60ml EPDM rubber roof system to entire flat roof areas
- NOTE: EPDM system to include plates, screws, termination bars and glue
- Rubber roof system to be terminated up to 12" up wall where applicable
- Install RMS strip on any rubber transition areas
- Install full ice and water shield in transition area
- Install custom bent metal on "shelf"
- Transition custom metal into new rubber roof system
- Install new shingles on small strip to match existing as close as possible in rubber to shingle transition area
- Install Titan post anchor for railing system (if applicable)
- Install termination bars along eaves in gutter after rubber roof install
- Re-install siding on house wall where applicable
- Any bad wood will be replaced on a time and materials basis not to exceed \$69 per labor hour, (upon inspection there appears to be possible wood damage, new roof sheathing included if needed, any rafter damage to be discussed if found)

Additional Scope of Work Possibilities

- Install pressure treated wood railing system to include handrails, posts and spindles
 - **Please add \$1,600.00 to price below**
- Install "ProVia" Legacy Series entry door to match existing (see attached Spec sheet)
 - **Please add \$1,741.00 to price below**
- Remove existing door, frame in for new window (approx. 36" x 42"), install new PlyGem Premium Series Double Hung window (white/white), install new siding to match existing as close as possible and cover interior with new drywall (mud/sand texture), install new casing and jambs
 - **Please add \$2,795.00 to price below**

Area to be kept neat and clean at all times. Gutters to be cleaned upon completion of job. All workmanship is guaranteed for **20 YEARS** and materials are guaranteed for **20 YEARS** with certificates presented upon completion of the job.

Shelter From The Storm Roofing, Inc. is fully insured in accordance with the state of Wisconsin's unemployment, workers compensation and liability requirements.
