

Review and approve Contract Change Order No. 1 with MP Systems (d/b/a PieperLine) for the Kossow Road and Abbott Drive Traffic Signal Installation project.

Details:

Engineering is requesting approval of Contract Change Order No. 1 in the amount of \$6,473.48 with MP Systems. This change order reflects additional cost to install 2" dia. and 3" dia. conduits to finish connection of the signal system. This change order also reflects the final cost changes for quantities that went over the original bid amount.

Contract Extra for Conduit Installation and Restoration:

The 2016 WisDOT project was to install the underground conduits for this project. However, these conduits were not installed and the installation is added to the City's project. Due to field conditions, vacuum excavation was needed.
