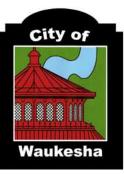

Details:

This Contract Change Order provides payment for additional work performed for Arcadian Avenue Utility and Street Improvements – Concrete Pavement project awarded to Zignego Company, Inc. Additional length of sanitary sewer lining was added on Perkins Ave and S. Porter Ave due to heavy infiltration and overall poor condition. Items 1 through 3 paid at unit bid prices.
