Adam Panoff appeared before the committee at its request. Donald Crouse appeared from Donnie Boys. Panoff was convicted of OWI from May of this year. He had a previous OWI 14 years ago while in college. Panoff has an occupational driver's license with interlock on his vehicle. He is not working for Crouse right now; he has worked for him prior; Crouse said there is not a doubt in his mind that Panoff would be a responsible server. Panoff crashed his motorcycle on a dead end street; he is thankful no one else got hurt. He has completed his class and AODA assessment. Crouse does not allow his bartenders to drink while working; it is a basis for termination. Panoff said his accident has changed his view on drinking and driving; he has a 2 year old daughter and his accident scared him and he thinks about it everyday.
