Proposal for 2018 Drop-Off Center Fee Adjustments

Major Adjustments:

- 1) Elimination of allowance for unlimited bulky trash disposal through the Season Passes. Now, Season Passes only available for yard material drop-off and 2 bulky trash drop-offs per year.
- 2) Introduction of Day Passes for both yard material and bulky trash drop-off.
- 3) Senior citizens (aged 62 and over) no longer free disposal for bulky trash materials. Added, charge, still significantly discounted.
- 4) Added charge of 25 cents for every gallon of latex paint drop-off, for all aged customers.
- 5) Reduced charge by \$1 for vehicle loads of yard material.
