THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS FOLLOWS:

SECTION 1. The Attorney, Clerk and Assessor shall be paid the salaries opposite his/her respective office in full compensation for his/her service as such officer for the period time during his/her term beginning January 1, 2006 and each January 1 in consecutive years 2007, 2008 and ending December 31, 2009:
