The Grantor, Windings Maintenance Corp., for good and valuable consideration, hereby conveys to the Grantee, City of Waukesha, Wisconsin, a permanent sidewalk easement across the following described property in Waukesha County, Wisconsin, referred to as the Easement Area, subject to all of the terms below: See Attached Exhibit A.

TERMS OF EASEMENT

- 1. **Grant of Easement.** The Grantor grants to the Grantee, a perpetual easement and right of way over, upon, across and through the Easement Area to install and construct a sidewalk. The easement shall be for the use of the public, to cross upon the sidewalk to be constructed in the Easement Area.
- 2. **Restrictions within Easement Area.** Grantor shall not do any of the following without the expressed, written and proper approval of the Grantee:
 - a. Change the grade elevations.
 - b. Excavate
 - c. Place any items or do any acts which reasonably be expected to interfere with Grantee's rights granted herein.
- 3. Removal of Items from the Easement Area. In order to perform any activities authorized in section 1, Grantee may remove any items from the Easement Area which are in violation of the restrictions of section 2. and Grantee shall not be liable for damage to such items resulting from removal. However, Grantee shall provide advance notice of work to be performed in the Easement Area and shall cooperate with Grantor to minimize damage to items removed from the Easement Area.
- 4. **Grantor's Use of Property.** Grantor reserves the right to use the Property for purposes which will not interfere with the City's full enjoyment of the easement rights granted hereby.
- 5. Covenants Run with the Land. All of the terms, conditions, covenants and other provisions contained in this Agreement, including the benefits and burdens, shall run with the land and shall be binding upon and inure to the benefit of and be enforceable by Owner and the City and their respective successors and assigns.
- 6. **Governing Law.** This instrument shall be construed and enforced in accordance with the laws of the State of Wisconsin.

- 7. **Entire Agreement.** This instrument sets forth the entire understanding of the parties and may not be changed except by a written document executed and acknowledged by all parties to this Agreement and recorded in the office of the Register of Deeds of Waukesha County. Wisconsin.
- 8. **No Waiver by Non Use.** Neither non-use nor limited use of the rights granted by this instrument shall constitute a waiver or partial waiver of the later exercise of enforcement of such rights.
- Severability. If any term or condition of this instrument is deemed invalid or unenforceable by a court of
 competent jurisdiction, such invalid or unenforceable provision shall be severed and the remainder shall
 remain fully enforceable.
