19	Whereas, the purpose of the agreement is to hire a shared professional Librarian to deepen	
20	learning opportunities for students, teachers, and parents via shared resources, digital access, and

25 26	THE	PARTIES AGREE AS FOLLOWS:
27		TARTIES MOREE ASTOLLOWS.
28	1	SCOPE of SERVICES. WPL agrees to hire, train, and equip a full-time degreed
29	1.	Librarian to provide services to both the School District of Waukesha and the Waukesha
30		Public Library. The Librarian, to be known as the Community Library Liaison, shall split
31		time between the schools of the School District, the public library, and other outreach
32		sites to be determined. WPL shall administer performance reviews of the Community
33		Library Liaison with substantial input from the School District of Waukesha. WPL agrees
34		to provide office space, computer equipment, phone service, training, and standard City
35		of Waukesha benefits for the Community Library Liaison. The duties of the Community
36		Library Liaison shall be rendered at the WPL, at the schools of the SDOW, or in other
37		locations that meet Library and School goals as agreed upon between the parties.
38		
39	2.	<b>TERM</b> . The term of this agreement is April 1, 2018, through the end of the school year,
40		2021. The agreement may be extended by the mutual, written agreement of the parties.
41		
42	3.	COMPENSATION AND PAYMENT. The School District of Waukesha shall
43		reimburse the Waukesha Public Library for the full-time salary, not including fringe

reimburse the Waukesha Public Library for the full-time salary, not including fringe benefit costs, for the position of the Community Library Liaison. For this agreement, the annual cost for the services provided by the Community Library Liaison as described in this agreement is \$51,403 for 2018. This amount is mutually agreeable as representing the total cost of salary for this position. The School District of Waukesha shall make an annual payment upon receipt of the invoice. The Waukesha Public Library shall be responsible for all employee benefits, estimated to be around \$38,430 annually. The Waukesha Public Library remains the employer of the Community Library Liaison and

shall therefore approve vacation or other time off, but shall do so only after consultation with the School District of Waukesha.

Should there be a variance in the salary or benefits of the Community Library Liaison during the contract year due to city council action on personnel costs, the Waukesha Public Library Board may seek an amendment to this contract by providing documentation of city council action within 30 days of that action.

In subsequent years of the agreement, the parties shall determine the cost for maintaining the position for the calendar year 2019 no later than November 1, 2018, and shall determine annual compensation by using the most current WPL salary schedules/estimates.

4. **TERMINATION**. Either party may terminate this agreement for any reason by giving 90 days written notice to the other party. If this agreement is terminated, WPL shall refund a prorated portion of any payment made by the School District of Waukesha pursuant to paragraph 3 above for services paid for but not rendered.

5. **EMPLOYMENT STATUS**. The parties agree that the Community Library Liaison shall perform services as an employee of Waukesha Public Library and not as an employee of the School District of Waukesha. The Community Library Liaison shall remain an employee of the WPL for all purposes. The employment and personnel policies of the City of Waukesha and WPL shall prevail as they relate to the System Administrator's employment. WPL and the City of Waukesha shall maintain and be responsible for worker's compensation insurance and payments to the current system manager.

6. **AGREEMENT**. This document contains the entire agreement between the parties. It may not be modified except by written agreement signed by the duly authorized agents of the parties.

7. **COSTS OF ENFORCEMENT**. The parties agree that in the event legal action is necessary to enforce any term or condition of this Contract, then the breaching party will pay the non-breaching party's costs incurred in such legal action, including actual attorney fees. If judgment is taken against the breaching party, then such actual costs of enforcement will be added to the non-breaching party's judgment.

 8. **SEVERABILITY**. If any term of this Contract is unenforceable under law for any reason, then to the extent the unenforceable term can be severed from the remainder of this Contract without affecting the enforceability of the remainder of this Contract or substantially frustrating its purpose, it shall be so severed, and the remainder of this Contract shall remain in effect and enforceable.

9. **GOVERNING LAW AND JURISDICTION**. This Contract will be construed and enforced according to the laws of Wisconsin. The parties agree that if a lawsuit is necessary with respect to this Contract, it will be filed in the Circuit Court for Waukesha County, Wisconsin. The parties consent to personal jurisdiction in Wisconsin, and waive all jurisdictional defenses.

10. **CORPORATE AUTHORIZATION**. The individuals executing this Contract on behalf of the Parties represent that they are duly authorized to bind the Parties contractually. The Parties represent that the execution of this Contract is not prohibited by the Parties'
