Municipal Lot Parking Regulation Changes – ADHOC Downtown Parking Committee Recommendations

Details:

These items listed below were discussed and voted on by the Buildings & Grounds committee and relate to changes recommended by the ADHOC Downtown Parking committe. The item ID's list both rescinded items and new items. All items were approved by consent at the March 5, 2018 B&G meeting.

#18-0279 Rescind previous parking resolution dated 4/5/12 as it reads "Establish No Parking 2am to 5am in Municipal Lots 2, 6, 7 & 9".

#18-0280 Please approve No Parking, 2:00 am to 5:00 am Except with Permit in Municipal Lots 2, 6 and 7.

#18-0281 Rescind previous parking resolution dated 1/17/06 as it reads "Establish 3 Hour Parking Monday to Saturday with no permit parking in Municipal Lot 6".

#18-0282 Rescind previous parking resolution dated 1/17/06 as it reads "Establish 3 Hour Parking Monday to Saturday with no permit parking in Municipal Lot 6".

#18-0283 Please approve 3 Hour Parking, 7:00 am to 7:00 pm, Except with Permit for all stalls in Municipal Lot 6. Previously designated 30 minute parking stalls on the northwest corner shall remain unchanged.

#18-0284 Rescind previous parking resolution dated 4/5/89 for Municipal Lot 8 only. Previous resolution reads "Establish 3 hour parking, Except Sunday, Except by Permit".

#18-0285 Please approve 3 Hour Parking, 7:00 am to 7:00 pm, Except with Permit for all stalls in Municipal Lot 8. Previously designated stalls described in ID#16-0730 dated May 17, 2016 shall remain unchanged.



#18-0286 Rescind previous 2/16/83 resolution that establishes Municipal Lot 9 as one-way traffic flow. Municipal Lot 9 will revert back to two-way traffic flow.

#18-0287 Please approve two handicap parking stalls in Municipal Lot 9. Two stalls will be located in the northwest most corner of the lot.

#18-0288 Please approve No Parking, 2:00 am to 5:00 am Except with Permit for all parking stalls on the west side of Municipal Lot 9 excluding the two handicap parking stalls.

#18-0289 Please approve 3 Hour Parking, 7:00 am to 7:00 pm, Except with Permit for all stalls in Municipal Lot 11. Previously designated three - 15 minute parking stalls at the north end of the east row by library shall remain unchanged.

18-0290 Please approve modification to the existing parking designation of "Permit Parking Only, 6:00 am to 4:00 pm, 3 Hour Parking All Other Times" to be for Monday to Friday only for said designated stalls in Municipal Lot 12. (this item was revised by the committee to remove the reference to 3 Hour Parking all other times). Revised item was approved unanimously.

#18-0292 Please approve 3 Hour Parking, 7:00 am to 7:00 pm on Saturdays, Sundays and Holidays for all stalls in Municipal Lot 12 excluding those designated for city maintenance vehicles.

Options & Alternatives:

None considered.

Financial Remarks:

Not every item approved above will incur a cost. Only locations that require a change of the sign message. Staff has identified 20 signs that will need to be replace at a cost of \$30 per sign. The cost to outfit the signs changes in the municipal lots above will be \$600.00 and covered by the 2018 B&G Sign Budget (3310.54141).

Executive Action:

If approved by Council, a resolution document covering all items listed will need to be executed by the Mayor and Clerk after the Council Meeting.

Committee Recommendation:

The Buildings and Grounds Committee approved these items at their March 5, 2018, meeting and will appear under the Consent Agenda for the March 20, 2018, Council meeting.
