# **City Administrator Highlights**

- Held a session of the City employee leadership class. We are half-way through the program with this Leadership Class.
- Held a kick-off meeting with BWBR, the architecture firm hired to complete preliminary designs of City
  Hall. All aldermen are invited to attend a workshop session on April 4 from 1:30-2:30pm in room 207. A
  Core Team group has been formed who will hold regularly scheduled meetings with BWBR. The Core
  Team includes: Ald. Helgestad, Ald. Rodriguez, Ald. Boyle, Kevin Lahner, Mayor Reilly, Jennifer
  Andrews, Fred Abadi, Gina Kozlik, Rich Abbott, Chris Pofahl, Katie Jelacic, and Rebecca Pederson.
- Held a Downtown Response Team meeting with a newly formed group of City employees representing Community Development, Public Works, Police, and Parks. The group is working together to be able to more quickly address any concerns that are raised Downtown.
- Held discussions regarding the Mindiola Park proposal.
- Held a Director's Meeting with all Department Directors.
- Attended the Waukesha County Center for Growth Board of Director's meeting.
- Attended the Carroll President's Inauguration Ceremony.

## **Clerk/Treasure Updates**

- The Spring Election will be held on Tuesday, April 3, 2018 at all city-wide poll locations. To find poll locations and find other election information, the statewide voter system can be accessed at <a href="https://myvote.wi.gov/en-us/">https://myvote.wi.gov/en-us/</a>
- Offices on the Spring Election ballot are: Supreme Court Justice & Circuit Court Judge seats, County Supervisor, Mayoral, Municipal Court Judge, City Attorney, Aldermanic District # 6, and a Referendum to eliminate the Office of State Treasurer. - 814 absentee ballots were mailed to those voters who have a valid absentee ballot application on file on Monday, March 12th. We continue to receive and process absentee ballot requests daily.
- In-Office Absentee Voting begins March 19, 2018 and will continue through March 30, 2018, during the hours of 8 am to 4:30 pm. The Friday before the election, March 30<sup>th</sup>, the hours are extended to 5 pm.
- There will be 156 Absentee Ballots delivered and administered at 9 care facilities by Special Voting Deputies during the week of March 19th.
- March 14, 2018 was the deadline for voters to register online or by mail. Any voter who
  wishes to vote in the Spring Election must now register in-person at the Clerk's Office by
  March 30, 2018; or voters may register at their poll location on Election Day, April 3, 2018.
- Gina held a new poll worker training class on March 16<sup>th</sup> for 24 new poll worker recruits. Sandee recertified 5 Special Voting Deputies.
- Continuing work with the vendor for our License Manager Software upgrade this upgrade
  will provide enhancements to the licensing system which will allow us greater efficiencies
  when issuing licenses and permits from our office, including licenses for alcohol
  establishments, bartenders, and street closing and block party permits.
- Reviewing delinquent 2016 personal property bills and preparing for chargebacks that are due to be invoiced this month.
- Gina met with IT Staff to discuss necessary items for completion prior to moving forward with transitioning additional departments onto the Munis invoicing system.
- Second installment tax payments are due on March 31<sup>st</sup>. With that being a Saturday, the due date will be extended into election week.

## **Information Technology Department**

IT has been focusing on a few security initiatives as well as disaster recovery planning:

- The first security initiative is remediating vulnerabilities. We have been running weekly vulnerability scans against the firewall and network, then remediating any vulnerabilities found.
- The second security initiatives is data access governance and Active Directory Security, which
  was a 2018 CIP Project. We completed the installation of Stealthbits. This system, protects
  credentials and data from insider threats, audits changes, and automates tasks for security and
  compliance across the infrastructure.
- IT completed the first phase of another 2018 CIP Project with the implementation of Zerto. Zerto is a disaster recovery and business continuity software specifically for virtualized data centers and cloud environments. Zerto is a disaster recovery solution that allows us to meet recovery point objectives of less than 10 minutes and recovery time objectives of less than 30 minutes, dramatically reducing data loss in the event of a disaster.

# **South Street and Gaspar Street Utility and Street Reconstruction:**

- Last week the contractor was able to complete the project start up tasks such as traffic control, erosion control, safety fencing setup, sawcutting, tree clearing, and mobilization. They were also able to make progress on the sanitary sewer relay along South St.
- This week the project activities will also increase within the limits, and specifically around the Gaspar St. and West Broadway intersection. The contractor will be utilizing a second underground utility crew to work on two areas of the project at the same time next week. Starting on Monday (3/12), this second crew will be placing a sanitary sewer manhole on West Broadway near the Gaspar St. intersection. During this work, the Gaspar St. and West Broadway intersection will be closed, as well as, Gaspar St. from West Broadway to South St. Access will be maintained to municipal parking lot #9 from Gaspar St./Park Pl. during this work.
- After the new manhole at the West Broadway/Gaspar St. intersection is placed, they will be moving to work on a sanitary manhole and property lateral on Gaspar St., just south of the Avalon Square underground parking access driveway. During this work, Gaspar St. will be closed at the Avalon Square Driveway. Access to the Avalon Square driveway will be open from W. Main Street. At this time the contractor will reopen the West Broadway and Gaspar St. intersection for access to Municipal Parking Lot #9 via West Broadway/Park Pl.
- Once the two sanitary manhole work locations are complete, this crew will begin the water main relay starting at the Gaspar St. and West Broadway intersection, and working their way down Gaspar St. towards South St. Once the Water main work begins, the contractor will again close the Gaspar St. and West Broadway intersection, as well as, Gaspar St. from West Broadway to South St. Access will be maintained to municipal parking lot #9 from Gaspar St./Park Pl. during this work. The Sanitary manhole work and water main work being completed by the second crew is anticipated to take approximately 1 week to complete.

• In addition to the work along Gaspar St. above, the contractor will also continue on the sanitary sewer relay along South St. With multiple crews in a very constrained work zone, please use caution when navigating to the access point listed below, as well as, walking through the very active work zone. All of the dates and time are subject to change and are weather dependent.

## Access Points:

South St. Municipal Parking Ramp: Enter/Exit via Wisconsin Avenue.

Municipal Parking Lot #9: The easiest access will be via South St. from N. Barstow St. Access from the north end of the lot will be via West Broadway or Gaspar St. depending on the work activity that day/time (see above schedule).

Avalon Square Underground Parking: Enter/Exit via Gaspar St. from/to the north (W. Main St.)
