## **City Administrator Highlights**

- Held two sessions of the City employee leadership class. There are only two sessions and a service project remaining with the current class.
- Participated in the Bond Rating call for the City. We did receive confirmation back that we have retained our rating at Aa2.
- Participated in the 2-day Strategic Plan Workshop.
- Meet with a representative of Aurora to generally discuss Aurora's plans for the future.
- Participated in a discussion on the 2018 marketing/branding strategy for Downtown Waukesha.
- Hosted a Leadership Class Alumni session where we invited Paul Decker to come speak on generational differences in the workplace. Our goal is to continue to keep those who have taken the leadership class engaged in conversations around leadership.
- Held discussions regarding the Mindiola Park proposal.
- Held regularly scheduled meetings with Rich Abbott, Fred Abadi, Nancy Faulk, and Chris Pofahl.

## Clerk/Treasure Updates

- Gina held Chief Inspector training class on March 30<sup>th</sup>.
- Election material for the 15 locations was prepared and packed for delivery on Monday, April 2<sup>nd</sup> by Public Works crew, along with equipment.
- Public test for voting equipment was held March 26<sup>th</sup>, which was attended by Chief Inspectors.
- The deadline for pet licenses was March 31st. Any renewal pet licenses received after April 1, 2018, will incur a \$5 late penalty.
- Gina attended the Strategic Planning Workshop on March 26<sup>th</sup> and March 27<sup>th</sup>.
- Gina, Sandee and the Chief Inspectors attended the epoll book demonstration at the City of Brookfield on March 27th.



- As of March 27<sup>th</sup>, 1,459 absentee ballots have been issued; 405 of those absentee ballots have been from in-person voting.

## South Street and Gaspar Street Utility and Street Reconstruction

- Last week the contractor was able to continue the sanitary sewer relay along South St., and has completed up to just past the South St. and Gaspar St. intersection. They also were able to complete various sections of the water main replacement along Gaspar St., West Broadway, and some sections of South St. AT&T was also able to complete underground communication cable relocations along South St. in conjunction with the other on-going work within the project.
- This week the contractor will continue with the sanitary sewer relay along South St., and
  depending on weather and working conditions, may be able to complete the last remaining
  section by the end of the week. If the contractor is able to complete the sewer relay before the
  end of the week, they will then turn to the working on the water main replacement along South
  St. from Gaspar St. to N. Barstow St.
- During the work along South St., the contractor may also complete some sanitary sewer lining along Gaspar St. as well. During the lining process you may notice a smell of resin or glue around the project area, and potentially outside of the project limits depending on the weather. The smell is non-toxic, and will dissipate after the process is complete. If a definitive timeframe is known for the lining process I will send out a follow up update mid-week.
- With the completion of the water main work on West Broadway and Gaspar St., the contractor has opened up access to Municipal Parking Lot #9 via West Broadway or Gaspar St. This access will remain the same during this week's work activities, unless the sanitary sewer lining is worked into next week's schedule. In the event this happens I will update everyone on the planned access. Since the sanitary work along the east end of South St. is still on-going, the easiest access to and from Lot #9 will be via West Broadway or Gaspar St. Access via South St. from N. Barstow St. will be restricted during work activities this week.

#### **Access Points:**

South St. Municipal Parking Ramp: Enter/Exit via Wisconsin Avenue.

Municipal Parking Lot #9: Via Gaspar St. or West Broadway.

Avalon Square Underground Parking: Enter/Exit via Gaspar St. from/to the north (W. Main St.) or from/to the south (West Broadway Only).
