2.	Comment:	Clearly show the location of all transformers, utility service meters, and appropriate screening for final approval.
	Response:	The transformer is screened by the dumpster enclosure and shrubbery. The electrical meter and panels on the exterior of the buildings have been relocated to the walls facing the adjacent building. (In the alleyway between the two buildings). See revised plans and elevations attached.
3.	Comment:	All paved areas should be curbed.
	Response:	Acknowledged. Please see current civil drawings dated 5.18.18.

- 7. Comment: Indicate bicycle parking on site plan to meet City Ordinance 22.53.

Response: Bike rack indicated on civil drawing C1 site note #14.

8. Comment: The Plan Commission suggests both buildings be proposed at the same time or that the developer consider using one larger building instead of the two smaller buildings.
