We hereby submit an estimate for:

Restoric, LLC (Restoric) shall complete a third phase of the Waukesha Springhouse terra cotta mural conservation project initiated in 2014. The proposed work includes the conservation of two more murals in the studio. Restoric proposes the removal and conservation of the southwest "Brave Drinking Springwater" (Mural #8) and the southeast "Woman at Waterfall" (Mural #6) murals per the attached key. The work shall include the careful removal of the terra cotta murals with the back-up masonry intact, painted board-up of the openings, documentation of all conditions exposed by the remove of the murals, conservation of the murals in the studio per the Silurian marquee mural approach and the re-installation of the conserved murals.

We hereby propose to furnish labor and materials--complete in accordance with the above specifications, for the sum of **\$17,945 (estimate)** with payment to be made as follows:

Work to be scheduled for removal in November 2018 upon receipt of signed proposal and \$3,000 deposit. Work shall be completed over winter for reinstallation in the spring of 2019 as weather permits. Progress payments of no less than 20% of the Work submitted as work is completed. Final payment shall be due upon completion. A late fee of 1.5% shall be charged for all payments 30-days past due. This agreement is subject to binding arbitration.

All material is guaranteed to be as specified. All work to be completed in a workmanlike manner according to standard practices. Any alteration or deviation from above specifications involving extra costs will be executed only upon written orders and will become an extra charge over and above the estimate. All agreements contingent upon strikes, accident, or delays beyond our control.

This proposal is subject to acceptance within **10** days and it is void thereafter at the option of the undersigned
