### RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution items were approved at the xxxxx Buildings & Grounds meeting by a vote of 4 aye, 1 nay and brought forward to the xxxx Common Council meeting for discussion under the Buildings & Grounds Report.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#18-1031 Modify existing zone of 4 Hour Parking, 7AM to 7PM, Except Sundays and Holidays on the north side of W. Main Street to be from 285 feet west to 115 feet west of Buckley Street.
- ID#18-1032 No Parking Any Time on the north and south sides of Paramount Court from 180 feet east to 350 feet east of the centerline of Paramount Drive.
- ID#18-1033 Modify existing parking prohibition on the south side of Perkins Avenue from White Rock to E. Main Street to allow parking on the south side from 50 feet east to 300 feet east of centerline of Adams Street.
- ID#18-1034 Installation of a stop sign on southbound Carriage Drive at Michigan Avenue.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in his office as part of the original City records.
