



That I have surveyed, divided and mapped part of the Northeast 1/4 of the Northwest 1/4 of Section 12, Town 6 North, Range 19 East, in the City of Waukesha, Waukesha County, Wisconsin, bounded and described as follows:

Commencing at the North 1/4 corner of said Section 12; thence South 0°07'48" East, 48.01 feet along the east line of said Northwest 1/4 section to the south line of East Broadway (C.T.H. "D") and to the point of beginning; thence South 88°49'39" West, 508.67 feet along said south line; thence South 29°30'09" West, 112.27 feet along said south line to the east line of S.T.H. "59" and the beginning of a 3021.95 foot radius non-tangent curve to the right, whose chord bears South 3°19'44" East, 446.55 feet; thence southeasterly, 446.95 feet along the arc of said curve and said east line; thence North 87°49'43" East, 539.52 feet to the east line of said Northwest 1/4 section; thence North 0°07'48" West, 533.48 feet along said east line to the point of beginning.
