RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolutions were approved at the September 17, 2018 Buildings & Grounds meeting and brought forward to the October 2, 2018, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

ID#18-1309	Modify the existing Deaf Child signing on S. Grand Ave. to be southbound starting at 1712 S. Grand Ave. and northbound starting at 1827 S. Grand Ave.
ID#18-1310	Modify the existing No Parking Any Time on the west side of N. Grandview Blvd. to be from the northwest corner of Madison Street to 200 feet north.
ID#18-1311	Establish No Parking Any Time on the west side of N. Grandview Blvd. from the southwest corner of Madison Street to 150 feet south.
ID#18-1312	Establish No Parking Any Time on the east side of N. Grandview Blvd. from the southeas corner of Madison Street to 150 feet south.
ID#18-1313	Establish No Parking Any Time on the south side of Madison Street from the southeast corner of N. Grandview Blvd. to 160 feet east.
BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
