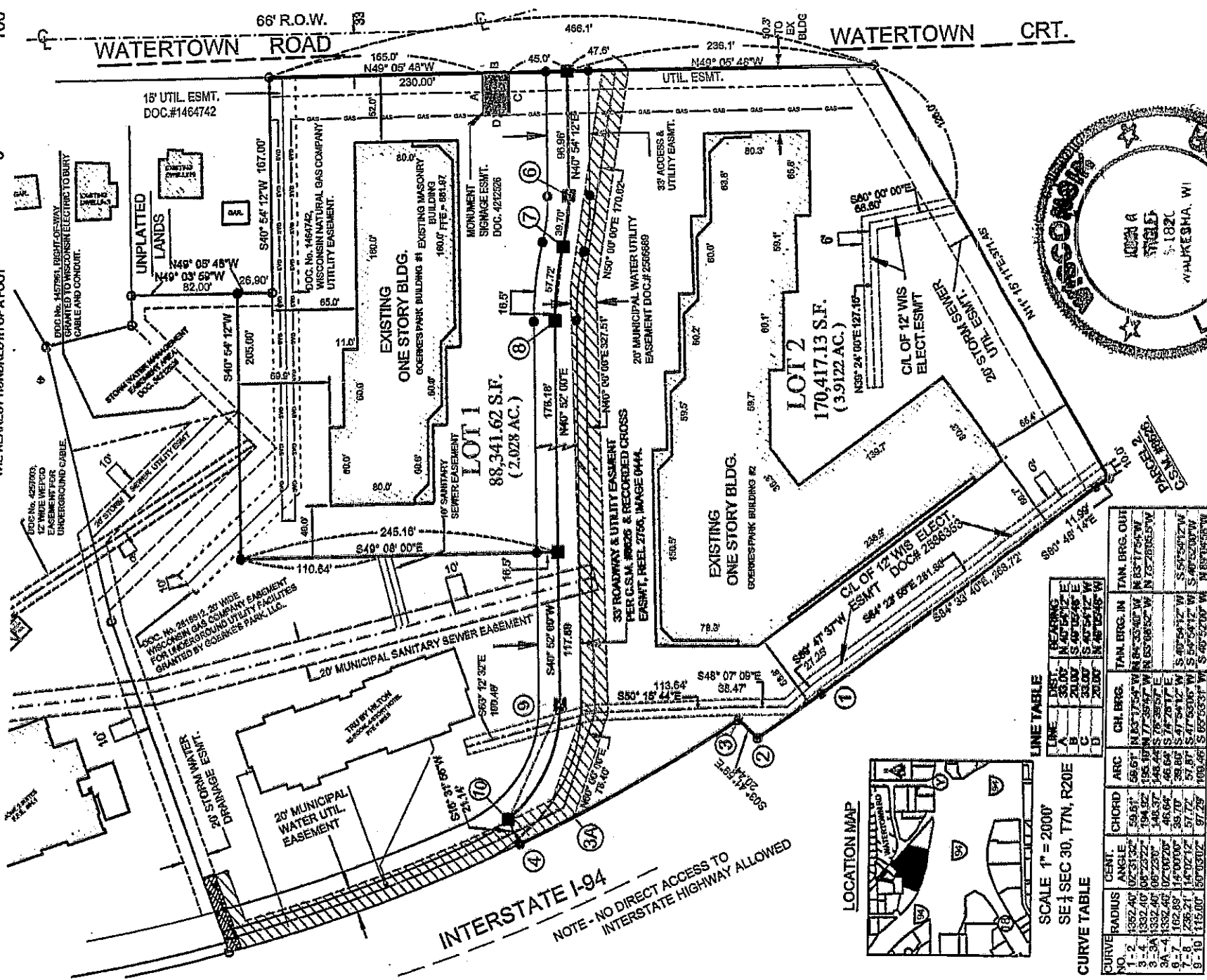

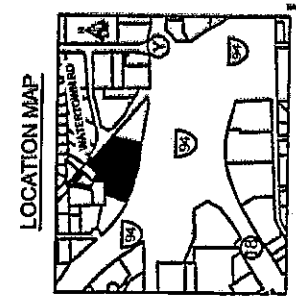

NOTE - NO DIRECT ACCESS TO INTERSTATE HIGHWAY ALLOWED



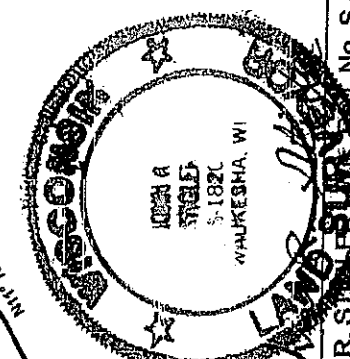

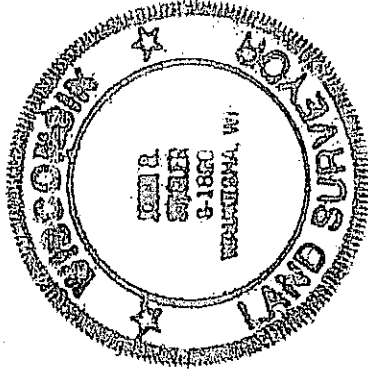

SURVEYOR'S CERTIFICATE:

I, John R. Stigler, professional land surveyor, being duly sworn on oath, hereby depose and say that I have surveyed, divided and mapped the following land bounded and described as follows:

A. redivision of Lot 1 of Certified Survey Map No. 11671 recorded in Volume 117 of Certified Survey Maps on Pages 59 - 64 inclusive as Document No. 4327227 being part of the Northeast Quarter (NE ¼) and the Northwest Quarter (NW ¼) of the Southeast Quarter (SE ¼) of Section 30, Town 7 North, Range 20 East, Town of Brookfield, Waukesha County, Wisconsin further bounded and described as follows: Beginning at the northerly corner of Lot 1 of Certified Survey Map No. 11671; thence South 40°54'12" West 167.00 feet along the westerly line of said Lot 1; thence along the boundary lines of Lot 1, Certified Survey Map No. 11671, North 49°05'48" West 26.90 feet; thence South 40°54'12" West 205.00 feet; thence South 49°08'00" East 245.16 feet to the centerline of a 33 feet wide roadway and utility easement; thence South 40°52'00" West on said centerline 117.89 feet; thence Southwesterly 100.46 feet along the arc of a curve of radius, 115.00 feet, curve center lies to the west, chord bears South 65°53'31" West 97.29 feet; thence South 16°31'56" West 21.14 feet; thence Easterly 195.10 feet along the northerly right-of-way line of Interstate I-94 and the arc of a curve of radius 1332.40 feet, curve center lies to the north, chord bears South 77°39'47" East 194.92 feet; thence South 03°41'59" East 20.44 feet; thence Easterly 59.61' along the arc of a curve of radius 1352.40 feet, curve center lies to the north, chord bears South 83°17'54" East 59.61 feet; thence South 84°33'40" East 268.72 feet; thence South 80°45'14" East 11.99 feet; thence North 11°15'11" East 371.45 feet to the southerly right-of-way line of Watertown Court; thence North 49°05'48" West along said right-of-way line of Watertown Court and Watertown Road 466.11 feet to the place of beginning. 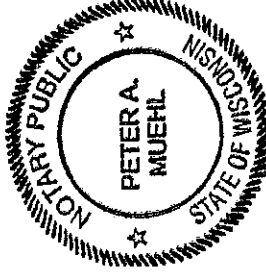

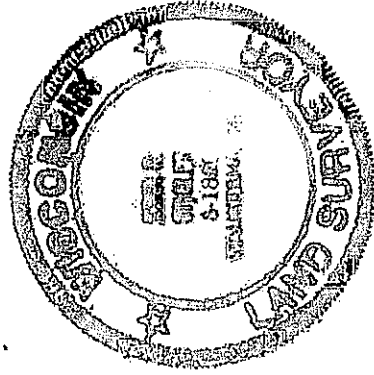
