Subject:

Review and act on a 2019 CIP budget adjustment for the use of impact fees and other designated revenue towards the construction of Meadowview Park.

Details: Meadowview Park development will occur in several phases, the first of which is beginning this year. The project has been combined with the Northview Road Phase II construction contract, both for economies of scale and for coordination. As part of the bypass construction project, a land sale for a temporary easement occurred, and We Energies rented a portion of the park as a staging area. Both of these items resulted in funds generated to be used towards development of Meadowview Park. These, along with regularly collected Impact Fees, are being requested to be used in 2019. Waukesha Parks, Recreation & Forestry (WPRF) staff worked with the Finance Director Rich Abbott to make this amendment.

Options & Alternatives:

WPRF staff reviewed options & alternatives with Rich Abbott, and both agreed utilizing existing designated funds was determined to be the best option.

Financial Remarks:

Request and recommend 2019 CIP budget adjustment of approximately \$51,280 to project account 5565.68290 New Park Development (Meadowview Park) utilizing the following:

- Special Revenue Fund 0240 Impact Fees (\$31,180 plus accrued interest)
- Rental/Lease revenue (\$5,600)
- Sale of City Property (\$14,500)
