## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the March 4, 2019, Building and Grounds meeting and brought forward to the March 19, 2019, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#19-0334 Approve No Parking Any Time on the north and south sides of W. Moreland Blvd. from Delafield Street to Gascoigne Drive.
- ID#19-0335 Approve No Parking Any Time on east and west sides of Gateway Drive from E. Moreland Blvd. to Paramount.
- ID#19-0336 Approve No Parking Any time on the north side of Paramount Drive from 60 feet east to 60 feet west of centerline of Gateway Drive.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
