Dear Mr. Singh,

The Waukesha Police Department conducted a compliance check on your business to ensure that minors were not sold alcohol. Your business failed the compliance inspection.

On 10/17/2018 at 6:48 p.m. an employee of your establishment, Ranjit Singh (DOB 08/04/1968), sold an alcoholic beverage to a minor. A minor was given permission by the Waukesha Police Department to conduct the compliance checks and the minor was accompanied by an officer.

City Ordinance number 9.16(2) prohibits the sale of alcohol to a minor and has a fine of \$313.00 for the violation. Continued violations of this nature will result in the Waukesha Police Department recommending to the Ordinance and Licensing Committee that your license be suspended, revoked, or not renewed.

Please educate your employees on the importance of properly checking identification cards for the legal sale of alcoholic beverages. Your business will be randomly checked in the future to ensure that there are no further violations. It is imperative that we all do our best to prevent minors from illegally obtaining alcohol.

Your "Class A" Beer & Cider License expires on June 30, 2019. Prior to your license being renewed, you are required to attend a City of Waukesha Ordinance and License Committee meeting on March 11, 2019 at 6:00 pm. The purpose of your attendance is for you to provide your plan of action to prevent the sale of alcohol to a minor in the future. Contact the City Clerk/Treasurer's Office at (262) 524-3550 if you are unable to attend your scheduled date listed above. Please remember that your attendance is mandatory in order for your license to be renewed effective July 1, 2019.
