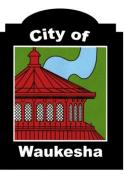

Review and act on Contract Change Order No. 4 with Super Excavators, Inc. for the Greenmeadow Sanitary Interceptor Sewer project.

Details:

The Contract Change Order details additional work completed by Super Excavators, Inc. as requested by the City of Waukesha:

Item #1 - W. St. Paul Ave. Storm Culvert Upsizing

In Change Order No. 2, the City requested the installation of an upsized storm culvert under W. St. Paul Ave. about 65 feet west of the proposed sewer crossing for the adjacent Greenmeadow sanitary interceptor sewer project. After approval of the change order by the City but before construction on the culvert commenced, the Wisconsin DNR requested several changes to the culvert design, specifically elevation, grading, and erosion control changes. These changes resulted in additional excavation, erosion control, and restoration expenses. Even with these changes, the overall cost of the culvert crossing is less than the \$442,495 budget amount that was approved as a part of the 2019 CIP for City-Wide Flood Mitigation and Improvements.
