PROJECT OBJECTIVE:

To prepare a National Register nomination for each of the following four properties in the City of Waukesha:

- 1) St. Mary's Catholic Church Complex 225 S. Hartwell Avenue
- 2) St. Luke's Lutheran Church 300 Carroll Street
- 3) Ted and Margaret Morey House 1516 Pleasant View Avenue
- 4) Paul and Thelma Strong House 617 Downing Drive

PROJECT UNDERSTANDING:

The four properties listed above were identified as potentially eligible for the National Register of Historic Places as a result of a 2013-2014 architectural and historical resurvey of the City of Waukesha that was completed/authored by me (Traci E. Schnell), while an employee of Heritage Research, Ltd. The results of that survey effort were confirmed at that time by Ms. Diana Penkiunas of the Wisconsin Historical Society's Division of Historic Preservation. Summaries of each property are included below, all of which were derived from the 2013-2014 report that I authored (photos are those which were taken by me and used in the 2013-2014 report).



St. Mary's Catholic Church Complex

(Eligible under Criterion C: Architecture)

Consisting of three buildings, the St. Mary's Catholic Church complex includes a striking 1960s Contemporary-style church (1965; and which is considered individually eligible), a rectory (1960), as well as a school that originally included convent quarters above (1953; 1960; ca. 1966). All combined, the religious property presents itself as a very good example of a 1950s to 1960s-era church complex. The architectural

firm responsible for the church was Wenzel, Zoller & Gunn (Elm Grove), while John J. Flad and Associates (Madison), designed the school/convent, rectory, as well as the school additions.



St. Luke's Lutheran Church

(Eligible under Criterion C: Architecture) Designed by the firm of Cooley & Borre & Associates (Park Ridge, Illinois), St. Luke's Lutheran Church (1966) is a very good and highly intact example of a 1960s Contemporary style church that includes thirty-six bas relief carvings along its entrance elevation, as well as a large expanse of multi-faceted glass designed by Bernard O. Gruenke of Conrad Schmitt Studios.



Ted and Margaret Morey House

(Eligible under Criterion B: Significant Persons) Wisconsin-born Theodore "Ted" Morey entered into the field of real estate at the age of nineteen and, six years later, moved to Waukesha. His real estate interests evolved into becoming a land developer. "Westowne," the first of the over thirty subdivisions that he developed during his lifetime, is the subdivision in which he resided from 1927 until 1949. In circa 1940, Morey remodeled his original 1927 home into the

Colonial Revival-style residence seen today. Although Morey resided in a number of different homes during his real estate career, it is this house on Pleasant View Avenue that best reflects his real estate accomplishments.

Paul and Thelma Strong House

(Eligible under Criterion C: Architecture)

Designed by Milwaukee designer Roy Jacobs, this tri-level, 1950s Contemporary-style house was completed in 1956. While perhaps not considered particularly modern for today, the home was considered rather modern for its time. Featuring strong horizontal lines and overhanging eaves, it stands largely intact, featuring such original materials as stone veneer, as well as cedar and vertical board and batten siding.

All aspects of the project will be completed by me, Traci E. Schnell. Know that of the over thirty National Register nominations that I have completed (and that have been officially National Register-listed) to date, I do have previous experience completing multiple nominations for a single municipality, also a result of an award of grant funding from the National Park Service. In 2009-2010, the City of West Allis was awarded funding to cover a total of four nominations—three individual and one historic district nomination. All four were completed (solely by me and while an employee at Heritage Research, Ltd.) on time (within the grant funding cycle) and were successfully listed in the National Register of Historic Places between 2010 and 2011.

NATIONAL REGISTER NOMINATION DELIVERABLES/ TASK ELEMENTS

Products generated by this project will include those deliverables cited in both the Work Program and the Request for Proposals, and will consist of the following:

- A. Accomplish and complete all research (above and beyond that gathered at the survey level) to thoroughly understand the historical or architectural importance and relevance of each property.
- B. Thoroughly tour and inspect each property and prepare appropriate architectural descriptions. Although no physical changes are understood to have occurred to any of the four properties since the 2013-2014 survey, digital photos of all properties will be taken in order to update the existing survey photos in the Wisconsin Historic Preservation Database (WHPD). Any new information found will be added to the WHPD records.
- C. Prepare a complete draft of each nomination.
- D. Send a draft of each nomination to the City of Waukesha's Landmarks Commission, if requested.
- E. Address any review comments offered by the City and/or the Commission.
- F. Submit all four individual nominations (an electronic and a paper copy) to the Historic Preservation Division of the WHS for review and scheduling. Each submittal shall include all the necessary materials including a USGS map, 4' x 6' digital photographs, floor plans, digital images, PowerPoint presentation for the Preservation Review Board (PRB), a 200-300 word web summary for posting on the WHS website, along with a completed nomination submission checklist--all as described in the Work Program. *An additional digital copy of all materials will also be submitted to the City of Waukesha, as requested.*
- G. Complete any final nomination revisions required by the WHS.
- H. Present nominations to the Preservation Review Board (PRB); the timing of which is subject to the PRB's schedule/calendar (See additional information provided in "Project Scheduling."
- I. Make any final revisions required by the PRB, after which the nomination will be returned to the WHS for transmission to the U.S. Department of the Interior.
- J. Attendance (if requested) at a Landmarks Commission meeting (following the completion of the nominations) to present findings.

PROJECT SCHEDULING:

The project award and completion dates noted in the Request for Proposals provide for an approximate 12-month work period. Accordingly, work will commence shortly after receiving the Notice to Proceed (it is assumed that a contract can be in place by no later than 15 September 2019). Although the project MUST conclude by no later than 15 August 2020, it would be my intent to submit all four nominations by or before early (February) 2020.

Because the presentation of the nominations to the PRB (the group of which meets four times a year; in February, May, August and November) may not occur for up to six to nine months after submission of the nominations to the WHS, presentation dates to the PRB are unknown at this time (and could possibly occur after the grant cycle has concluded). Presentation, however, is included in the project deliverables. Also, due to the unknown timing regarding the presentation of the nominations to the PRB, I would like to submit all materials by no later than early 2020 to be able to more likely secure a PRB date in 2020. Unless the Commission or the property owners are opposed, it would also be my preference to submit the two church properties together and the two residential properties together, rather than submitting all four nominations at one time. Presentation of all four nominations at a single review board is highly unlikely; therefore the paired approach is suggested. Although the likelihood of two nominations being scheduled for the same PRB date is possible, it's not entirely out of the question that only one may make the agenda for any given PRB meeting.

Please also be aware that while PRB meetings are most often held at the Wisconsin Historical Society in Madison, there is an attempt to hold at least one of the four meetings at another location in the state. Known past locations include La Crosse, Milwaukee and Oshkosh; however, they are not limited to those locations.

OTHER COMMITMENTS -- tes | Historical Consulting, LLC

At this time, I have few professional commitments after August 15th (the current grant cycle). I will be finishing up two other National Register nominations, completing a tax credit rehabilitation application, as well as working on a few small WisDOT survey projects, so I do not foresee any significant workload issues.
