Review and act on Contract Change Order No. 2 with Super Western, Inc., for the Northview Road Phase 2 and Meadowview Park Improvements-Concrete Project.

Details:

Sussex Lane Storm Sewer Extension

The City requested the installation of storm sewer adjacent to Sussex Lane to prevent street icing issues currently affecting the corridor during the winter months. The source of the roadway flooding is from private sump pump laterals currently discharging to the roadway. The project was released for bid earlier this year resulting in project costs 300-400% greater than originally budgeted. Super Western is currently working in the City and is willing to complete the additional storm sewer on Sussex Lane for \$73,760.30 compared to the original bid of \$218,835.00. This 500 linear foot storm sewer extension will provide sump pump lateral connections to relieve the reoccurring street icing issue before the winter of 2019.
