## RESOLUTION

BE IT RESOLVED by the Common Council of the City of Waukesha, Wisconsin that the Board of Public Works in conformity with Chapter 349 Wisconsin Statutes shall place the following official traffic signs and signals at the intersections and upon the highways indicated; that said signs and signals shall be so located as to give adequate warning to users of the highway and no provision of the Traffic Ordinance of the City of Waukesha, with respect thereto, shall be enforced unless and until such signs are erected and in place and sufficiently legible to be seen by an ordinarily observant person.

The following resolution was approved at the December 2, 2019, Building and Grounds meeting and brought forward to the December 17, 2019, Common Council Meeting for approval under the Consent Agenda.

All resolutions or parts of resolutions inconsistent with or contravening this resolution are hereby repealed.

- ID#19-1488 Extend the existing No Parking, Loading Zone, 8:30am to 9:30am, 2:30pm to 3:30pm, Monday to Friday to include the next parking stall to the east adjacent to 329 W. Main Street.
- ID#19-1612 Install a speed feedback sign to be placed on the eastbound direction of traffic on Madison Street near 4<sup>th</sup> Street.
- ID#19-1613 Modify the No Parking zone on the north side of White Rock Avenue to be from the center line of E. Main Street to 200 feet northeast.

BE IT FURTHER RESOLVED that the City Clerk shall file this resolution in their office as part of the original City records.
