#### SWMA-Frame Park Commons

Matt Cary from Pinnacle Engineering Group, the civil engineer onboard for the project, addressed what an Up-Flow Filter is for the Board. It is a storm sewer manhole with an insert that captures the sediment that gets picked-up, mainly from parking lots, and then, inside this filtration device, it filters out this sediment and then every couple of years these cartridges need to be taken out and replaced as part of the annual maintenance package.

Ald. Pieper questioned whether there are other project using similar technology. Engineer Damien stated this is a private facility and will be maintained by the group there. He is not aware of any other projects using this technology in the area.
