Review and act on Contract Change Order No. 1 with Advance Construction, Inc., for the Sanitary Sewer Force Main Relay/Rehabilitation-2019 project.

**Details**: Contract Change Order No. 1 is for additional work performed for the Sanitary Sewer Force Main Relay/Rehabilitation-2019 project awarded to Advance Construction, Inc. Additional force main length was due to minor route changes to avoid utilities and adjustments made to the actual connection locations. Additional concrete pavement was necessary due to the poor condition of the surrounding panels and it was requested by Clean Water Plant staff to replace the remaining driveway at the station on Coral Dr due to the poor condition.
