Subject:

Study and recommend improvements to the surrounding intersections adjacent to the Butler Middle School site with a priority being on Michigan Avenue and Hine Avenue. (Revised to be that Michigan Ave. & Hine Ave. intersection shall receive curb ramp upgrades and crosswalk marking improvements).

Details:

This item was brought forward by Ald. Corey Payne. With the school district remodeling Butler Middle School, Ald. Eric Payne would like Engineering to review the major intersection adjacent to Butler Middle School and consider improvements if necessary. At this point, no specific intersection or improvement measure have been identified.

The committee discussed this item at their December 16, 2019 B&G meeting. Ald. Corey Payne indicated that the only intersection he is concerned with is Michigan Ave. & Hine Ave. He feels the curb ramps and crossing marking have not been updated in years and would like to see that work done. The committee agreed. Ald. Cummings made a motion which read "move to approve upgrades to the curb ramps and crossing markings at Michigan Ave. & Hine Ave. and the funding for said improvements would come out of the remaining funding in the Buildings & Grounds Safety Projects budget Acct. No. 3310.54141 (approx. \$3,000) and any remaining funds from the B&G budget Acct. No. 3310.54140 (approx. \$200). The motion was second by Ald. Corey Payne. The committee voted unanimously for the motion.

Options & Alternatives:

No specific remedies or alternatives were discussed and the committee did not request any.

Financial Remarks:

The committee indicated that funding for said improvements would come out of the remaining funding in the Buildings & Grounds Safety Projects budget Acct. No. 3310.54141 (approx. \$3,000) and any remaining funds from the B&G budget Acct. No. 3310.54140 (approx. \$200). Note that Public Works is expecting to use \$3,500 from Acct. No. 3310.54141 to purchase a Radar Speed Feedback sign approved at Dec 2 meeting. Remaining balance will be approx. \$3,000. Engineering explained to the Committee that said left over funding usually does not automatically roll into 2020.
