**Re:** Recommendations of Job Evaluation Committee

The Job Evaluation Committee (JEC) met on 1/7/2020 to review the job points of three positions. The changes to our organization structure were recommend by the <u>Baker Tilly Evaluation of our Organizational Structure</u>, <u>Efficiencies and Staffing Levels</u> presented in August 2019. The three positions reviewed were:

- 1. **Lead Operator:** Create two positions (to be filled from within) to replace one eliminated supervisor position, eliminate Distribution Operator II and Water Supply Operator II positions.
- 2. **Customer Service Supervisor** Reclassify current Billing Coordinator to an exempt supervisor position due to increased customer volume and monthly billing
- 3. **Assistant Operations Manager**: Reclassify existing supervisor position and recognize increased responsibility for the operations department.

The JEC consisted of: Joe Ciurro, Dan Duchniak, Tom Krause Jon Kuzba, Lynn Gomez, and John Vick. The JEC reviewed the value of the job duties using <u>WMS and Company's System for Job Measurement and Pricing, EQUI-COMP®</u>. The application of the points system resulted in the changes in pay and job points as indicated below:
