# **Engineering Division:**

#### **New City Hall**

City Hall Update (3 week look ahead from 1/15/20)

- Marriott, the Concrete Contractor, has finalized the excavating, pouring and backfilling of the SW footing and lower wall. The final column footings were poured this week.
- This week there was great progress made on the steel erection and steel decking installation. The contractor began to build the temporary stairs to all floors of the building. The building steel is as high as it is going to go, so you can really see the building take shape from all street approaches to the building. The views a the City from the floor are impressive.
- New structural steel is being delivered almost daily. The work assembling the steel structure is ongoing and will continue for several weeks.

#### **Greenmeadow Sanitary Interceptor Sewer**

• The only work remaining includes the demolition of the Greenmeadow pump station site.

### **2020 N Barstow Street Utility and Street Improvements**

- The contractor will be starting project work beginning on **Monday February 17, 2020.** Starting on the 17<sup>th</sup>. The contractor will be setting up project traffic control, detour route, erosion control, and also will be mobilizing equipment and materials to the site. Water main installation is expected to begin on Tuesday and will be the primary focus of the project for approximately the first 6 weeks.
- The contractor will be utilizing two crews for the water main installation and will be starting in two separate locations. One crew will be starting at the intersection of Barstow St. and Riverfront St., and working their way south/east along Barstow St. towards W. Main St. The second crew will be starting on Barstow St. near E. North St., and working their way along Barstow St. towards St. Paul Ave. Also, in conjunction with these two crews, the Waukesha Water Utility will also be working to complete the lining of the existing water main underneath the Fox River.
- Traffic Control/Access
   Starting on Monday February 17<sup>th</sup>, Barstow St. will be closed to through traffic from W. Main St. to E. St. Paul Ave., and from E. St. Paul Ave. to E. North St. The Barstow St./Main St., Barstow

St./St. Paul Ave, and Barstow St./North St. intersections will remain open to traffic. During the work described above, Riverfront St. will also remain open to vehicular access and parking. Detour routes will be posted. **Please follow the traffic control devices and signs.** Through traffic should not enter the work zone and shall utilize an alternate route.

#### Transit:

- Routes 1, 2, 3, 4 and 15 and the Wisconsin Coach Lines Route 901 are on detours with the start of the Barstow construction project.
- Proposed adjustments to Route 7 due to changes to the hospital routing of the bus as well as shortening the west end of the Route 7 are on the Council Consent Agenda for Feb. 20th.
- Transit staff continues to work with SEWRPC on the 2021-2025 Transit Development Plan
  process. SEWRPC has started outreach efforts with UWM at Waukesha and the Waukesha County
  Aging and Disability Resource Center and will continue over the next month to receive input on
  transit needs from the business community, educational entities and social service agencies.
- Seeking quotes for wayfinding sign project at the Transit Center to help direct the public through the Transit Center and to/from the Skywalk to the new City Hall.
- The 2020 paratransit buses on order with Arboc and are expected to be delivered in early June.
- The 2021 fixed route buses are on order and are expected to be delivered in late January 2021.
- Researching new AVL systems that can improve real time information to passengers and provide more data to staff.
- Working on obtaining quotes for Unit Heater replacements at the bus garage.
