## MEMORANDUM

RE: Lawn Service Agreement

We requested proposals from three firms for the include mowing, trimming, and weed control at 28 Utility owned sites based on a two-year agreement. The proposals were due on February 14<sup>th</sup>. These services are provided on an as needed basis; however, the dollar amount being approved assumes 29 cuttings per year, 1 weed and feed application and three cuttings of the Saylesville Reservoir area.

Expense account #6260 has \$24,432 allocated for this work. In 2019, we spent \$21,820.

In the past, when only one proposal is received, we have compared it to the proposal last received for the services (2017 in this case). The difficulty in comparing total cost is the variable of the number of actual cuttings that were performed.

The increases in cost of one round of cutting went from \$820 to \$1,040, which is not substantial in my opinion given the three-year time difference.

**Recommended Motion:** Move to approve the 2020 and 2021 lawn care services to Bertoni Enterprises out of Sussex, Wi for an amount up to \$26,832 each year.
