Review and act on Contract Change Order No. 2 with Donohue & Associates, Inc., for Greenmeadow Sanitary Infrastructure Improvements.

Details:

This Contract Change Order provides for one additional review of a request for information by Donohue & Associates as outlined in Contract Amendment No. 2 as well as a credit for geotechnical investigation work that was unnecessary for the Greenmeadow Sanitary Infrastructure Improvements project.

<u>Item #1 – Additional Review of Request for Information</u>

Contract Amendment No. 2 in the scope of services, outlined the review by the consultant of four (4) request for information (RFI) submittals related to shaft construction, tunnel construction or horizontal directional drilling and three (3) RFIs related to open cut sanitary sewer or storm sewer construction for a grand total of seven (7) RFI reviews. During the course of construction, the consultant reviewed one (1) additional RFI related to the open cut sanitary sewer work for a grand total of eight (8). The contract amendment contained a provision for cost of \$1,420.00 per each additional RFI review.

Item #2 – Credit for Geotechnical Investigation Work

The geotechnical program of the project called for 330 feet of rock coring as well as 35 tests and analyses of the rock. Because of the bedrock elevations encountered during construction, the entire amount of rock coring and analyses budgeted were not necessary.
