SECTION 1. Subsection 12.10(2)(d)(15) of the Waukesha Municipal Code is hereby amended to read as follows:

- (2) DEFINITIONS. The following terms shall be defined as follows:
 - (d) (Am. #14-10) "Nuisance Activity" shall mean any of the following activities, behaviors or conduct occurring on or within two hundred (200) feet of a premises whenever engaged in by premises owners, operators, occupants or a person or persons associated with a premises:
 - 15. Animal violations as defined by <u>Chapter 33</u> or §12.05(18), §11.22, §11.24, or §12.05(18), Waukesha Municipal Code.
- **SECTION 2**. All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.
- **SECTION 3.** This ordinance shall take effect and be in force from and after the date of its passage and publication.
