5. Discussion and Recommendation

ID#20-1378

Discussion and recommendation: Enact an ordinance allowed under Wis. Stat. Section 341.65(2)(a) which prohibits any unregistered vehicle from being located on a highway or public street and also governs the immobilization, removal and disposal of those unregistered motor vehicles up to and including those in possession by a dealership.

Ald. Browne has made this referral. He said there is a low level of cooperation from the car dealerships in his district regarding where they are parking inventory and sometimes employee cars.

The Police have observed that it is unregistered vehicles parked on our streets creating a nuisance. An officer involved made a recommendation to the City Attorney's Office regarding this. Browne said his referral was based on language from the Attorney's Office.

Johnson said based on his previous discussion with Browne this involves a dealership off Davidson Road. He has been looking and hasn't noticed cars on Davidson. Browne said the police came to him for help with enforcement so he thinks it involves more than one dealership and more than one neighbor complaining.

Ald. Rodriguez said we have existing ordinances that cars must be registered, which goes through Community Development to investigate and issue citations. She asked Browne what his goal is. Does he want the vehicles towed after one infraction, which seems excessive. Browne said his understanding is that there is not something on the books for this and it is something that the City Attorney and the Police Department thought would be a good idea to put on the books to give them more authority for enforcement. Rodriguez is not in favor of towing vehicles for parking on the streets. She said that unregistered vehicles are not allowed to park on the streets.

The Committee feels more information from the City Attorney and Police Department/Parking Enforcement would be helpful. This will go on the next agenda for further discussion. Johnson will contact the Parking Agent to discuss this.
