Show topo across trail and where parking lot drainage path will ultimately drain to so no drainage problems are created.
- 6. Parking lot setbacks do not meet City Ordinance.
- 7. Storm sewer lateral, sanitary sewer lateral are proposed to be abandoned in City right of way. Contact City Engineering staff Chris Langemak for requirements.
- 8. Show ADA parking stall. Label ADA path from ADA parking spot to building and ADA parking spot to City sidewalk.
