Good morning Mr. Damien.

The folks in the Water Utility Department suggested we reach out to you to see if something can be done to consider a credit for our residence, due to the circumstances surrounding our exorbitant waste water usage this past quarterly billing cycle. Though we just paid the full bill, because we are responsible citizens and did not want to be late with our payment, we would appreciate consideration of our request for credit.

We live at 1326 Mohican Trail in Waukesha in 53189 and purchased this property from a builder and closed 10-29-19. Subsequent to this, as Fall and Winter of last year progressed, we notice the grading of the property did not move water at all in the east and southeast sides of our lot. Water encroached 1/3 of the way onto our patio and pooled in two areas and little moved forward toward the street and sewer system as it should have done. The landscaper attempted 3 times to get this grade corrected for us, and therefore re-seeding has needed to take place 3x. Needless to say, massive watering followed each of these corrections over the past 4-5 months.

Mr. Damien, the water bill we paid on Nov. 20th was \$1203.61 so a lot of waste water usage was due to this necessary watering, which we did not ask for nor expect. We expected, when buying a home with a yard that this was an established yard. This was far from the case. Though I paid this \$1203.61 this past Friday, Nov. 20th, will you please consider issuing us a credit to offset a lot of which was due to this re-seeded lawn watering?

The total in waste water usage was \$627.05. Our Customer #060206 and Account #228004005 for your reference.
