**Please Note:** The following budget/estimate is being provided according to the pricing established under the Master Intergovernmental Cooperative Purchasing Agreement (MICPA) with Racine County, WI and OMNIA Partners, Public Sector (U.S. Communities). The line item pricing breakdown from Attachment C: Bid Form should be viewed as the maximum price an agency will be charged under the agreement. Garland/DBS, Inc. administered an informal competitive process for obtaining quotes for the project with the hopes of providing a lower market-adjusted price whenever possible.

## Scope of Work: Building 1

- 1. Remove all existing roofing down to roof deck.
- 2. Install 2 staggered layers of 2" polyisocyanurate insulation mechanically attached to the wood deck and applied in hot asphalt adhesive on concrete deck.
- 3. Install  $\frac{1}{2}$ " wood fiber hardboard in a solid mopping of asphalt on both areas.
- 4. Install base sheet and a granular surface modified cap sheet with hot asphalt.
- 5. New wood blocking to be installed to accept new insulation heights.
- 6. Perimeter walls flashed utilizing granular surface flashing.
- 7. New pipe penetrations will be install utilizing new soldered galvanized tall cones with collars.
- 8. On the west wall, install new 24 gauge prefinished gutter with built in slope, 24 gauge 4" square prefinished downspouts. High back gutter which will be stripped into the new roof system. Install Scupper boxes and downspouts at north and south sides of buildings at the ends of Expansion Joint detail insultation cricket.
- 9. Rake edge at east wall, new 24 gauge prefinished strip in metal with 22 gauge continuous cleat.
