The City of Waukesha Parks, Recreation and Forestry Department mission is to be responsive and committed in providing essential park, recreation, and urban forestry services, making our community a desirable place to live, work and play. WPRF has years of experience as it relates to Community Development Block Grants with a wide variety of programs supported in part by these funds such as neighborhood playground programs, adaptive recreation programs and senior/older adult programs. Over the past 25 years, varied programs have been offered as part of our Adaptive Recreation Programs, including Summer Camp programs, special family evening events (including respite), community outings for adults with special needs, interpretive services for all ages and inclusion practices in our Before and Afterschool and Youth Development Programs. WPRF staff directly lead and assist with Adaptive programs and inclusion practices.

**11.** Describe the role specific staff will have in this project. Who will be responsible for managing the project, reporting to Community Development, preparing invoices, etc.?

The Staff involved in this project include a team comprised of: Recreation Services Manager, Mary Berg, Recreation Programmer, Gala Evers, Before and Afterschool Coordinator, Therese Jashinsky and a team of 100+ staff that complete forty hours of training in the areas of youth development, fun, age appropriate and engaging curriculum, behavior management, games/activities and CPR/First AID and Inclusion training throughout the year. The direct supervisor of this program, Recreation Programmer, Gala Evers has over 20 years' experience as a camp director, teacher, and program operations director. Gala will directly supervise the implementation and management of the project. This includes providing training and supervising staff, gathering, and collecting data for outcomes and ensuring that all aspects of the program come to fruition. Therese Jashinsky will provide direct supervision of the program staff. Recreation Services Manager, Mary Berg, will provide ongoing support to Gala and will be involved in the administrative section of the project.

**12.** Provide a concise description of the proposed project.

The Adaptive Recreation Programs offered through WPRF provide recreation opportunities for youth and young adults with physical and cognitive disabilities. The recreation programs are coordinated at ten Waukesha School District schools (Banting, Bethesda, Hawthorne, Heyer, Hillcrest, Lowell, Prairie, Randall & Rose Glen including Whittier Elementary in 2021) and other park sites in Waukesha during the summer months.

Two specific programs are provided to youth with disabilities:

1. Inclusion Services
2. Training for program staff to increase successful inclusion in before/afterschool program with our most vulnerable populations.

WPRF will collaborate with CESA 1 and other local agencies to provide additional training for program staff members to provide them with the necessary tools and knowledge in working with children with physical, behavioral, and cognitive disabilities within our program setting.

Additional specialized training will also be provided to WPRF before/afterschool program staff to better support students with special needs in our program. Our goal is for all children to be safe and successful in our before/afterschool program and over the past ten years, the number of students in our program who have special needs has drastically increased. To provide appropriate support and inclusion, the staff needs additional specialized training.

Inclusion Services are provided to youth who request these services to participate in a WPRF program or as identified through the School District of Waukesha or City of Waukesha Park, Recreation and Forestry Department.

WPRF promotes inclusion in all our recreation programs and we have experienced an increase in requests for inclusion/accessibility services.

17. Describe the need filled for your program or project.

The City of Waukesha Parks, Recreation & Forestry Department is committed to providing a comprehensive and inclusive recreation programs to people of all abilities. Special accommodations are needed at times for programs, and the CDBG funding assists with additional services needed in these programs. The need for additional specialized training for WPRF before/afterschool program staff is needed to continue to offer quality programming and meet the needs of our most vulnerable youth populations. Our number one goal is to have all students in the program safe and successful. Since the program began twelve years ago, the number of students with special needs has increased drastically. In 2020, Between nine sites and an enrollment 850 students, we had approximately 58 students with identified special needs. This does not include the 100+ students who have not formally been identified with special needs but are struggling. We continue to see an increase in students displaying signs and behaviors associated with anxiety and trauma and other social emotional concerns. While

staff are trained in behavior management, CPR/AED, youth development, program activities, and fostering healthy relationships, we have seen an increased need for specialized training and support in topics such as Autism Inclusion, Positive Behavior Intervention Systems, Social Communication, Emotional Regulation and Transactional Support and more. To ensure all students are safe and successful in our program, our team must be equipped with these types of specialized trainings annually. Through this grant over the past three years our staff have reported an increase awareness, increase knowledge, and have gained additional tools to help support the work they do in before and afterschool. Each year we continue to see an increase in children that can successfully stay in our program as reflected by increased trainings provided to our staff. Through more adaptive staff trainings, increased staff knowledge and a better “tool” gained from these trainings, staff report less “burnout”, better connectivity to students and their families and more passion in the work they do.

The CDBG funding request is to continue to train our staff in support for inclusion and meeting the needs of students with adaptive services in our most disadvantage and vulnerable pockets in the City of Waukesha. The schools we will be targeting are Banting Elementary, 55% of students disadvantage with 18% disability, Hawthorne Elementary, 57% disadvantage with 26% disability, Heyer Elementary with 58% disadvantage and 17% disability and Lowell Elementary with 46% disadvantage and 23.4%. and Whittier Elementary 78% disadvantage.

**2022 Measurable Outcomes**

- 100% of before and afterschool staff will attend at least one specialized training in the areas of inclusion and working with students with special needs and behavior challenges. (data source: staff professional development attendance records)
- 90% of before and afterschool staff attending specialized training will report an improvement in behavioral management and inclusion skills after attending specialized training. (data source: staff professional development surveys)
- 60 students with disabilities will attend before and afterschool programs and youth recreation programs. (data source: attendance and participant documentation)
- 100 students struggling with anxiety and trauma including behavior disorders will attend before and afterschool programming and recreation programs. (data source: attendance, participant documentation and SDW referral)
