Details:

The Contract Change Order details additional work completed by D.F. Tomasini Contractors, Inc., at the request of the City:

Item #1 – Additional Sanitary Sewer Replacement

After the bid, an adjacent section of sewer was noted as requiring replacement to correct a flat slope. This required additional pipe, manholes, and pavement and sod restoration.

Item #2 - Changed Site Condition - Existing Sanitary Manhole No. 2334

While connecting to the existing downstream sanitary manhole on Algoma Terrace, a concrete collar approximately 7 feet wide was discovered around the manhole that prevented connection of the new sewer to the manhole. After the discovery, the existing sewer was temporarily reconnected and the excavation backfilled to protect the area while a new structure was ordered to replace the existing manhole.

Item #3 – Replacement Grinder Pump Station – Frame Park

Moreland Boulevard to replace the existing pump station that has operational and capacity issues that has led to sewer backups at the bathroom in the past, including two events last year.
