- 2. Staff feels the proposed commercial space may be better situated to the West near the intersection of Bank and Brehm Streets where parking is available, or to the south along the river where a more tranquil setting can be provided for outdoor seating.
- 3. A retail presence should be considered for the east and west building along the St. Paul Ave frontage.
- 4. Architectural detailing will be important at the ground level of the buildings where interior parking is being provided adjacent to sidewalks and prominent public views.
- 5. The Developer should work closely with the Parks Dept. to coordinate landscaping and architectural details of the buildings where adjacent to park land, especially for the units with ground level access.
