- 1. Add sidewalk along street frontage.

- 8. Add note to drawings: Limits of final City street pavement and curb and gutter removal and replacements to be marked by City Engineering staff in field.
- 9. Add note to follow City driveway apron detail. Show driveway in accordance with city detail.
- 10. Obtain geotechnical soil boring information for pond design.
- 11. Provide basin map to quantify amount of drainage from off-site. Confirm if pond design is affected.
- 12. Storm water plan lists soil type is D per Ordinance. What is that referring to?
