Company Mission:

Work Proposed:

Window Restoration + Tuning

We perform our window tuning on a time and materials basis in part because no two windows are the same, and because of the options you choose can greatly affect the time it takes to do each window. This approach allows you to start with a select window or windows and expand the project from there at your discretion. Several windows are highlighted in attached images and order form for budgeting purposes.

Job Description:

Window Restoration + Tuning

Remove windows to our facility in Shorewood for this restoration to take place to avoid mess and contaminants at your house. Once removed we may temporarily board up openings on request if work is to be performed in the colder months or for security purposes.

Paint will be removed taken to near bare wood. Once window is prepped accordingly, we clean any lingering debris, fill any gouges/ nail holes, prime, and paint with two coats premium paint. Color to be selected by owner. If current color not available we can do a color match. Remove and replace any deteriorated glazing.

Clean hardware original to the windows. If any windows have missing hardware we will replace to match original as closely as possible. We will confirm hardware with owner prior to ordering.

Replace any broken glass.

All windows glazing will be assessed and repaired where necessary, followed by an oil based primer and paint to match.

Rotten, severely dried out or weathered wood will be addressed with Abatron wood restoration epoxy.

Re-glue any joinery that has begun separating

Windows that have been removed, once restored, we then reinstall and tune as necessary.

This will include: Affixing top sash fully up into its opening making sure top and bottom sash meeting rails line up and latch fully. Replacing sash cords and any missing stops.

Note: Trim "stops" removed to access window sashes, if painted, may need touch up painting upon completion. We may perform touch up painting or leave for owner.

Re-securing, re-placing or cleaning existing hardware.

Finally we recommend adding metal interlocking weatherstripping around the lower sash window and a vinyl gasket between the sash meeting rails.

Please identify which windows you'd like us to start with, you may expand the project to other windows throughout the home or change the scope of work as you see fit.

All work including set up, removal, restoration, reinstallation, cleanup and travel to be performed at \$75/hr. plus the cost of all materials and expendable supplies.

To track our time and keep you informed, we complete and share with you daily time and materials logs and are happy to discuss the process, progress, and any options that arise as frequently as you would like.

Time & materials work Invoiced and paid weekly as needed.

Payments due directly upon receipt of invoice.

1/2% interest per month on all payments 5 days overdue.
