4	This is an agreement for CAFÉ consulting services provided to the Bridges Library System		
5	(Bridges) located at 741 North Grand Avenue #210, Waukesha, WI 53186 by the City of		
6	Waukesha Public Library (WPL) located at 321 Wisconsin Avenue, Waukesha, Wisconsin, 53186		
7			
8	WHEREAS, WPL developed an integrated library system, Catalog Access for Everyone (CAFÉ), b		
9	contracts with several libraries with the assistance of Waukesha County Federated Library		
10	Syster	n, and	
11			
12	WHEREAS, Bridges and WPL, by mutual agreement transferred the governance and funding		
13	from WPL to Bridges (then known as Waukesha County Federated Library System) on April 1,		
14	2011,	and

16	<b>WHEREAS</b> , the purpose of this agreement is to advance the objectives of Bridges and WPL for integrated library services (ILS) within the county, and

18 19	WHEREAS, the integrated library system (ILS) requires staffing for management, development		
20	and maintenance; and		
21	and m	ainternance, and	
22	WHER	EAS, this agreement is authorized by Chapter 43, Wisconsin Statutes.

24	Now, therefore be it resolved that in consideration of the mutual covenants set forth herein,		
25			
26	THE PARTIES AGREE AS FOLLOWS:		
27			
28	1.	SCOPE of SERVICES. WPL agrees to provide consulting services to Bridges Library	
29		System for CAFÉ shared automation (ILS) activities for participating libraries. The CAFÉ	
30		System Administrator, a Waukesha Public Library employee, shall provide full-time	
31		consulting services to manage the CAFÉ ILS. WPL shall administer performance reviews	
32		of the CAFÉ System Administrator with substantial input from Bridges Library System.	
33		WPL agrees to provide office space (90 square feet), computer room (155 square feet),	
34		phone service, and computer equipment for the consultant at the library. The duties of	
35		the consultant shall be rendered at the WPL, at the Bridges Library System, or in the	
36		member libraries unless otherwise agreed upon between the parties.	
37	2	TERM. The town of this agreement is leavened 2022 through December 24, 2022. The	
38	2.	<b>TERM</b> . The term of this agreement is January 1, 2022, through December 31, 2022. The	
39 40		agreement may be extended by the mutual, written agreement of the parties.	
41	2	COMPENSATION AND PAYMENT. Bridges Library System shall reimburse WPL for the	
42	٥.	full-time salary and fringe benefit costs for the position of the System Administrator.	
43		For this agreement, the annual cost for the consulting services provided by the System	
44		Administrator as described in this agreement is <b>\$109,089</b> for 2022. This amount is	

mutually agreeable as representing the total cost of salary and fringe benefits for this

position. Bridges Library System shall make payments in equal quarterly installments

upon receipt of the invoices. WPL remains the employer of the CAFÉ System

Administrator and shall therefore approve vacation or other time off, but shall do so 48 only after consultation with Bridges Library System. 49 50 Should there be a variance in the salary or benefits of the System Administrator during 51 the contract year due to city council action on personnel costs, the Waukesha Public 52 Library Board may seek an amendment to this contract by providing documentation of 53 54 city council action within 30 days of that action. 55 In the event the parties to this agreement desire to extend this agreement, the parties 56 57 shall determine the cost for maintaining the consulting position for the calendar year 2023 no later than November 1, 2022, and shall determine annual compensation by 58 using the most current WPL salary and fringe benefits estimates/schedules. 59 60 4. **TERMINATION**. Either party may terminate this agreement for any reason by giving 90 61 days written notice to the other party. If this agreement is terminated, WPL shall refund 62 a prorated portion of any payment made by Bridges Library System pursuant to 63 paragraph 3 above for services paid for but not rendered. 64 65 66 5. **EMPLOYMENT STATUS**. The parties agree that the CAFÉ System Administrator shall 67 perform services as an employee of Waukesha Public Library and not as an employee of the County of Waukesha or the Bridges Library System. The CAFÉ System Administrator 68 69 shall remain an employee of the WPL for all purposes. The employment and personnel policies of the City of Waukesha and WPL shall prevail as they relate to the System 70 Administrator's employment. WPL and the City of Waukesha shall maintain and be 71 72 responsible for worker's compensation insurance and payments to the current system manager. 73 74 75 6. AGREEMENT. This document contains the entire agreement between the parties.
