<u>ID#23-5520</u> Update on Fundraising Efforts

City staff provided an update on fundraising efforts. The Parade Memorial Fund has received donations from 340 donors representing 33 states and Canada. The current total in the fund is \$250,000. The projects for the Main Street Memorial and Grede Park Memorial are on track. Commission members were encouraged to continue their fundraising efforts to help reach the rest of the goal.

ID#23-5521 Review and Approval of Waukesha Strong Tile Project

Carmen De La Paz presented the concept of a Waukesha Strong Tile project where community members would have the opportunity to customize 6'x6' clay tiles that would be installed in a wall at the Greded Park Memorial. The cost to complete a tile would be \$25. The tiles could be customized at three community events in 2023-2024. In addition, groups could sign up for times to customize clay tiles as long as at least 35 tiles were purchased in advance.
