ID#17-1293

Consider amendment of Mun Code sec 7.04(4) to allow the parking of vehicles on driveway aprons that are large enough to contain the entire vehicle, and make recommendation to Common Council.

Resident Tori Hexum spoke on this item. After road construction in front of her home, the terrace portion of her driveway was enlarged so that she has the space to park a vehicle in that portion of the driveway. She has been cited twice for this due to an ordinance that prohibits this city-wide.

Ald. Rodriguez supports this draft amendment, she doesn't feel it needs to be limited to only the property owner's vehicle.

Manion is supportive; he questions the 20' minimum requirement. Jankowski is in favor of no minimum apron length to utilize this parking area.

A motion was made by Rodriguez, seconded by Manion, to approve the draft ordinance with no minimum length of apron and no limitation on who may utilize the space for parking. The motion carried by the following vote:
